Vaccinations: Boarding guests must be up to date on vaccines. Dogs need Rabies, DA2PP, Bordetella & Canine Combo Influenza. Cats need Rabies, Leukemia, Annual FIV/Combo Test & RCCP. Proof must be provided or it is presumed the animal is not up to date on vaccines.

Fleas: (A free brief exam will be done by the boarding attendants to ensure the pet does not have fleas or ticks. **If we find any flea or ticks, we will have to treat the animal at the owner's expense.**

Illness: Some pets may become distressed while staying away from home and can become ill. This is a risk the owner agrees to take when boarding their animal and they will not hold Seneca Animal Hospital responsible for any symptoms that arise. The owner is responsible for paying for any treatment their pet may need while boarding. **Seneca Animal Hospital has the right to treat your pet for any issues that may develop.**

Bedding/Toys: We provide bedding for boarding guests. In the event that your animal ingests something (Bedding, toys, etc.) while boarding, the owner is responsible for paying for any and all treatment that is needed. The owner understands that it is their responsibility to inform the boarding attendants if their pet has any history of chewing.

Medications: There is a charge of \$4.00 per day for the medication and/or supplements to be administered. Supplements already in portioned food bags with meals will not be an additional charge, however SAH is not responsible for administering that supplement.

Personal Items: Seneca Animal Hospital is not responsible for loss or damage to personal items left with the pet.

Payment: The owner agrees to pay in full for all charges and necessary services rendered for the pet while they are boarding.

Photos: The owner gives the right for the staff to take photos of their pet and use them on the SAH website, social media pages and in any promotional material they chose, at no compensation to the owner.

Abandonment: If an owner neglects to pick up their pet within five days of the scheduled discharge and does not notify SAH within that time period, we may assume that the pet is abandoned and hereby authorize to adopt out or do what is deemed best for the pet.
