# Boarding Consent Form

## Vaccination Requirements

All guests must be up-to-date on the required vaccinations a **minimum of two (2) weeks** prior to the date of the reservation check-in. No exceptions will be made. Proof of **sufficient vaccination** must be provided at time of making the reservation. Otherwise, it will be presumed that the guest is not up-to-date and the reservation will not be created until sufficient proof has been provided.

## Fecal Testing and Parasite Policy

All boarding guests are expected to be flea, tick, and intestinal parasite free. **Proof of a negative fecal test is required by time of reservation check-in for canine guests.** Upon check-in, your pet will be examined for fleas and ticks by our boarding staff. If found, or if intestinal parasites are seen in a guest's stool during their stay, the guest will be tested and treated as deemed appropriate by one of our veterinarians at the owner's expense.

## Scheduled Check-In and Sunday After-Hours Check-Out

When your pet's boarding reservation is made, a check-in time for you and your pet will also be scheduled. At this time, check-outs do not require a scheduled time.

We now offer Sunday check-in and check-out for clients and their pets. There is an additional fee of **\$19.00 per pet** for this service. This option is **not available** on holidays or Saturdays. All other check-ins and check-outs **must be done** within our regular business hours. **Hours are subject to change.**

All boarding guests that are not picked up by 1:00pm on the day of check-out will be subject to an additional day boarding fee per guest. All guests who check-in and check-out on the same day will be charged a day boarding fee.

## Meals and Feeding

Seneca Animal Hospital boarding staff monitor each guest's eating habits during their stay. If a guest does not eat in a 24-hour period, staff members will first attempt to encourage eating by adding in a canned diet. If canned food is not provided by the owner, an appropriate canned diet will be offered from our hospital stock at the owner's expense. If a guest continues to refuse meals, the owner will be promptly contacted to discuss further care if needed.

## Medication Administration and Medical Boarding

Seneca Animal Hospital will administer one (1) medication per day as included in the boarding suite fee. Two (2) or more medications, as well as injections, are subject to an additional fee. Ample quantities of the guest's medications, along with clear written instructions, must be provided at the time of drop-off. Medication **MUST BE** in the original packaging/prescription bottle. Guests that require special medical care, will be boarded under supervision of licensed veterinary technicians (medical boarding) at an additional cost to the owner.

## Pet Belongings

Seneca Animal Hospital makes every effort to ensure your pet's belongings are returned in the same condition as they were received at check-in. However, no guarantee can be made against damaged or lost items. Seneca Animal Hospital **will not be held responsible** for the condition of any item when it is returned. Seneca Animal Hospital provides raised or plush beds with blankets for each suite. Bedding and large toys are not accepted.

### Multiple Pets and Shared Suites

We make every effort to accommodate owners' requests for shared suites. However we prioritize safety and in the event that staff members feel it is no longer safe for guests to share a suite, the guests will be separated. By signing this form, the owner accepts any risks should they request a shared suite for their pets. Should either pet exhibit any concerning or aggressive behavior that leads staff members to reconsider the safety of a shared suite, the guests will be placed in separate suits. The owner will be responsible for any additional charges that may occur as a result of this.

### Boarding and Day-Boarding Fees

Boarding is charged per pet, per night, and includes a suite, bedding, house diet, water, administration of one (1) daily medication, three (3) daily walks (for canine guests), daily cleanings, and daily care provided by our boarding attendants. Pricing is subject to change. Please ask a boarding staff member for current pricing.

### Illness, Injury, or Abandonment

Every effort possible is made to ensure our boarding guests have a safe and comfortable stay. However, Seneca Animal Hospital will not be held responsible or liable for any illnesses or injuries that may occur. Guests may experience illness, injury, or stress during their stay, Seneca Animal Hospital will take every reasonable precaution to prevent this. By signing this form, the owner acknowledges the risks associated with boarding their pet at our facility.

In the event, an owner neglects to pick-up their pet **within TEN days** of the scheduled pick-up date and does not notify our team within that time period, we will assume your pet(s) is abandoned. If your pet is assumed abandoned, we are authorized to adopt out or do what is deemed best for the pet. This does not relieve the pet's owner of charges incurred while their pet is boarding.

### Photo Consent Form

- I grant Seneca Animal Hospital permission to take photographs of my pet to use as they deem fit including, but not limited to, publishing to social media accounts and for promotional material, including on the hospital's website. I also grant Seneca Animal Hospital to use my pet's name and waive any compensation associated with the such use.

### Signed Consent to Board

I further understand that Seneca Animal Hospital will take the utmost care to follow my directives, but understand that the safety of Seneca Animal Hospital personnel, other boarding guests, and my own pet'(s) safety will supersede my directives. I understand that I am financially responsible for all fees for boarding, products, and services to which I have given consent to. I understand that payment is due in full at time of check-out.
